A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH AM-FM BUILDERS FOR THE PROJECT INSTALLATION OF STREETLIGHTS LOCATED AT ALABANG TO SUCAT, MUNTINLUPA CITY IN THE AMOUNT OF FIFTEEN MILLION THIRTY FOUR THOUSAND TWO HUNDRED SIX PESOS (PHP15,034,206.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2008 SUPPLEMENTAL BUDGET NO. 1 - INFRASTRUCTURE PROJECT UNDER THE EXECUTIVE BUDGET.

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the Construction Agreement for ratification;

WHEREAS, the *Installation Of Streetlights* located at *Barangay Alabang to Barangay Sucat, Muntinlupa City* is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on *April 28, 2011*, the City Government of Muntinlupa entered into Construction Agreement with AM-FM Builders for the construction of the project amounting to Fifteen Million Thirty Four Thousand Two Hundred Six Pesos (PHP15,034,206.00) as a result of a public bidding held on March 15, 2011;

WHEREAS, on April 18, 2011, the Bids and Awards Committee (BAC) approved Resolution No. I-03-001-11, "declaring the AM-FM Builders as the bidder with the Lowest Calculated Responsive Bid for the construction of installation of streetlights at Barangay Alabang to Barangay Sucat, Muntinlupa City and recommend the approval by the City Mayor;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod, to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro, in behalf of the City Government of Muntinlupa with AM-FM Builders for the project Installation of Streetlights located at Barangay Alabang to Barangay Sucat, Muntinlupa City in the amount of Fifteen Million Thirty Four Thousand Two Hundred Six Pesos (Php15,034,206.00) which amount shall be taken from the 2008 Supplemental Budget No. 1 - Infrastructure Project under the Executive Budget.
