**NOW THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED**, by the Sangguniang Panlungsod of Muntinlupa in session assembled that:

**SECTION 1.** The housing project shall contain a total area of 2,049 sq. m. located at *Purok 8, Wawa St., Barangay Alabang, Muntinlupa City*.

**SECTION 2.** The housing project of the *Pinagpalang Mariategue Homeowners Association, Inc.* will benefit the families who are residing in their area and under the *Community Mortgage Program of the Social Housing Finance Corporation.* 

**SECTION 3.** The issuance of Final Approval of Subdivision shall be done provided that the *Environmental Compliance Certificate (ECC)* shall be secured from the Department of Environment and Natural Resources.

**SECTION 4.** The developer-applicant shall comply with all legal requirements by the Zoning Office and by existing laws and ordinances.
