**ORDINANCE NO. 12-078**

**AN ORDINANCE AUTHORIZING THE CITY MAYOR HON. ALDRIN L. SAN PEDRO TO APPROPRIATE THE AMOUNT OF ONE MILLION FIVE HUNDRED SIXTY ONE THOUSAND TWO HUNDRED THIRTY PESOS AND 81/00 (Php1,561,230.81) FOR THE PROPOSED PROJECT INSTALLATION OF STREET LIGHTS LOCATED AT NBP MAIN ROAD, BARANGAY POBLACION, MUNTINLUPA CITY WHICH AMOUNT SHALL BE TAKEN FROM THE 2012 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF).**

**WHEREAS**, the Sangguniang Panlungsod shall authorize the Chief Executive to appropriate funds for programs and projects that were not included in the Annual Investment Plan (AIP)/Annual Procurement Plan of the City;

**WHEREAS**, Hon. City Mayor Aldrin L. San Pedro has submitted to the Sangguniang Panlungsod the proposed project Installation Of Street Lights Located At NBP Main Road, Barangay Poblacion, Muntinlupa City amounting to One Million Five Hundred Sixty One Thousand Two Hundred Thirty Pesos and 81/00 (Php1,561,230.81);

**WHEREAS**, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, *authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others*;

**WHEREAS**, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid the proposed project Installation Of Street Lights Located At Nbp Main Road, Barangay Poblacion, Muntinlupa City;

**WHEREAS**, there is an available fund from 2012 Executive Budget under the 20% Community Development Fund (CDF) for the said project amounting to One Million Five Hundred Sixty One Thousand Two Hundred Thirty Pesos And 81/00 (Php1,561,230.81);

WHEREAS, after the Bidding process has been conducted by the Bids and Awards Committee (BAC) the said project shall be submitted to the Sangguniang Panlungsod by virtue of Republic Act 7160, otherwise known as the Local Government Code of 1991 for its approval;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 6<sup>th</sup> Sangguniang Panlungsod, to authorize the *City Mayor Hon. Aldrin L. San Pedro*, to appropriate the amount of One Million Five Hundred Sixty One Thousand Two Hundred Thirty Pesos and 81/00 (Php1,561,230.81) for the construction of the proposed project Installation Of Street Lights Located At NBP Main Road, Barangay Poblacion, Muntinlupa City which amount shall be taken from the 2012 Executive Budget under the 20% Community Development Fund.

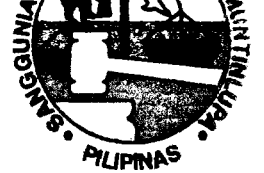
