WHEREAS, City Ordinance No. 02-047 adopt the Zoning Guidelines and Regulations for the City of Muntinlupa;



NOW THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the Sangguniang Panlungsod of Muntinlupa in session assembled that:

- **SECTION 1.** The housing project of **JAMCELS Villa Arciaga Neighborhood Association Inc.**, shall contain a total area of 8,000 sq. m. located at Purok 4, San Guillermo Street, Barangay Bayanan, City Of Muntinlupa.
- SECTION 2. The housing project of the JAMCELS Villa Arciaga Neighborhood Association Inc., will benefit the families who are residing in the area.
- **SECTION 3.** The issuance of Final Approval of Subdivision Plan shall be done after the issuance of Certificate of Non-Coverage from the Department of Environment and Natural Resources (DENR).

**SECTION 4.** The developer-applicant shall comply with all legal requirements by the Zoning Office and by existing laws and ordinances.
