A RESOLUTION FINDING BARANGAY APPROPRIATION ORDINANCE NO. 2011-11-03, SERIES OF 2011 CONTAINING THE ANNUAL BUDGET OF THIRTY NINE MILLION FOUR HUNDRED SEVENTY THREE THOUSAND FOUR HUNDRED EIGHTY FIVE PESOS (PHP39,473,485.00) OF BARANGAY AYALA-ALABANG, MUNTINLUPA CITY FOR CALENDAR YEAR 2012, WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BARANGAY, DILG CIRCULARS AND THE NEW LOCAL GOVERNMENT CODE OF 1991.

**WHEREAS**, Section 458 (a)1(i) of Republic Act 7160, otherwise known as the New Local Government Code of 1991, states that, the Sangguniang Panlungsod as the Legislative Body of the city...;

**(a) shall review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay”;**

**WHEREAS**, the total Appropriation for **Personal Services** amounting to **Php11,600,072.00** does not exceed the 55% limitation set under Article 423(d) of the Implementing Rules and Regulations of the Local Government Code of 1991 and Local Budget Memorandum Circular No. 53, dated June 29, 2007.

**WHEREAS**, the Statutory and Contractual Obligations have been provided in full:

- a) 10% for Sangguniang Kabataan (SK) - 3,947,345.00**
- b) 20% Community Development Fund - 1,489,497.00**
- c) 5% Calamity Fund(Regular income) - 1,973,624.25**

**WHEREAS**, the appropriation for **Discretionary Expenses** amounting to **Php603,631.00** does not exceed the 2% actual receipts derived from the 2011 Real Property Tax share;

**WHEREAS**, the proposed annual budget of **Barangay Ayala-Alabang** which is sourced out of funds derived from revenues certified as reasonably collectible based on existing tax ordinances by the Barangay Treasurer, City Treasurer, OIC Accountant, shows substantial compliance with the provisions of Local Government Code (R.A. 7160) and its Implementing Rules and Regulations (IRR);

**WHEREAS**, the appropriation for Compensation of Honoraria of Barangay Officials, Casual Employees, Barangay Health Workers and Day Care Workers must be in accordance with DBM-LBC No. 63, dated October 22, 1996; No. 86, dated June 8, 2007; No. 88 dated June 20, 2008; and No. 2009-92 dated September 3, 2009, First Tranche Monthly Salary Schedule; and No. 95 dated June 29, 2010, Second Tranche Monthly Salary Schedule and No. 97 dated May 11, 2011 Third Tranche Monthly Salary Schedule;

**WHEREAS**, the Compensation of Barangay Officials in the form of Honoraria shall be: first step of salary Grade 14 (Ph21,078.00) for Punong Barangay; and First Step of Salary Grade 10 (Php15,948.00) for Sangguniang Barangay Members, Barangay Treasurer, Barangay Secretary and SK Chairman. The Baragay Officials and Employees who are receiving honoraria higher than those authorized under this circular may continue to receive the same;

**WHEREAS**, the amount appropriated for **20% Community Development Fund** must be utilized for development projects of the barangay as embodied in the 2012 Annual Development Plan and must be in accordance with DILG Memorandum Circular No. 01, dated September 20, 2005 and DILG-DBM Joint Memorandum Circular No. 2011-1 dated April 13, 2011;

**WHEREAS**, the said Appropriation Ordinance was reviewed by the City Budget Office and was found to be **proper and in order**, having complied with the requirements set forth under the Local Government Code of 1991;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **6<sup>th</sup> Sangguniang Panlungsod**, finding Barangay Appropriation Ordinance No. 2011-11-03, Series Of 2011 containing the Annual Budget of **Thirty Nine Million Four Hundred Seventy Three Thousand Four Hundred Eighty Five Pesos (Php39,473,485.00)** of **Barangay Ayala-Alabang, Muntinlupa City** for Calendar Year 2012, within the scope of the prescribed powers of the Sanggunian Barangay, DILG Circulars and the New Local Government Code of 1991.

**ADOPTED**, by the **6<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** this 26 day of **March, 2012**, on its **71<sup>st</sup> Regular Session**.


