A RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO INCLUDE IN THEIR ON GOING REHABILITATION OF MERALCO ROAD NEAR THE PHILIPPINE NATIONAL RAILWAYS (PNR) SUCAT STATION A LOADING AND UNLOADING BAY, SPECIALLY NEAR THE PNR STATION.

WHEREAS, the General Welfare Clause of Republic Act 7160, otherwise known as the New Local Government Code of 1991, mandates that, *“the local government unit shall ensure and support the safety of its inhabitants, consequently, public works of national government should coincide with the program and plans benefiting its citizens”*;

WHEREAS, a laudable project of the Department of Public Works and Highways (DPWH) is the rehabilitation of drainage in Purok 2, Meralco Road, Barangay Sucat, Muntinlupa City which shall contribute to the easement of rain waters in the area;

WHEREAS, the same area is the site of the terminal of the Philippine National Railways (PNR) where a number of passengers arrive, thus, a heightened activity of human and vehicular traffic is expected;

WHEREAS, to ensure the safety of the passengers and the vehicles plying the area, a **loading and unloading bay** should be constructed;

WHEREAS, a great volume of jeepneys are using the main road as their loading and unloading place specially during rush hours, which affect greatly the flow of traffic on the said area.

NOW THEREFORE BE IT RESOVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod of Muntinlupa, to request the Department of Public Works and Highways (DPWH) to include in their on going rehabilitation of Meralco road near the Philippine National Railways (PNR) Sucat Station a loading and unloading bay, specially near the PNR station.

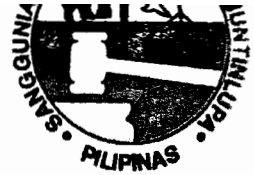
