WHEREAS, in consonance with the policy of according basic services, the national government granted the creation of the satellite office of the national Bureau of Investigation in the City of Muntinlupa;

WHEREAS, grateful for such grant, the Local Government defrayed some of the maintenance and operating expenses as well as contributed to the workforce of the said satellite office by allowing the deployment of city paid employees as part of their human resources;

WHEREAS, due to the proximity of the City of Muntinlupa to the Calabarzon and neighboring towns and cities in Metro Manila, people from the said areas flocked to the satellite office to avail of their services;

WHEREAS, the swelling in the number of clientele of the satellite office is expected as the basic services should be accorded to all the citizens of the country irrespective of locality; but special consideration should be given to the local residents of Muntinlupa it being the host local government unit;

WHEREAS, the City Government will provide the necessary computer set to be used on the said priority lane;

WHEREAS, the City Government through the Mayors Office together with the said agency will formulate the scheme and the whole system of operation for the proposed priority lane;

NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod, to request the satellite office of the National Bureau of Investigation (NBI) located in the city to provide priority lane for Muntinlupa residents.




