WHEREAS, the General Welfare Clause of Republic Act 7160, otherwise known as the New Local Government Code of 1991, mandates that, "the local government unit shall ensure and support the safety of its inhabitants, consequently, public works of national government should coincide with the program and plans benefiting its citizens";

WHEREAS, a laudable project of the Department of Public Works and Highways (DPWH) is the rehabilitation, maintenance and improvements of all national roads in the whole country, especially in our city which shall contribute to better travel of both motorists and commuters coming from Muntinlupa to any point of CALABARZON and Metro Manila and vice versa;

WHEREAS, the City Government of Muntinlupa through Hon. City Mayor Aldrin L. San Pedro is endorsing the conversion of certain City roads into national roads;

WHEREAS, the proposal of the City Government is to shift the responsibility of road maintenance and improvement to the Department of Public Works and Highways (DPWH) which has enough funds and logistics to do so;

WHEREAS, such conversion will result in the savings of city funds that will further boost the delivery of basic services to the people of Muntinlupa;

WHEREAS, one of the requirements for the conversion of city roads into national roads is a duly approved resolution from the City Council favorably endorsing the said conversion;

WHEREAS, the roads proposed to be converted into national roads are the following:

- 1. Susana Heights Access Road
- 2. Victoria Homes Main Road (Victoria Avenue, Don Pedro Reyes, Victoria Homes Subdivision)
- 3. New Bilibid Prison's Road (Magdaong Drive NBP, Makabuhay NBP, NBP & New Compound and MNHS, NBP Reservation)

WHEREAS, the City roads are within the standard of the Department of Public Works and Highway (DPWH) and has met the procedures and requirements for the conversion of the city roads into a national roads;

NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod of Muntinlupa, to endorse the conversion of certain City Roads into National Roads under certain conditions and favorably endorsing the same to the Department of Public Works and Highways (DPWH).

FURTHER RESOLVED, that the authority and control to maintain the maximum security, safety and order shall remain with the *Bureau of Corrections* inside the *National Bilibid Prison (NBP)*, Muntinlupa.

ADOPTED, by the 6th Sangguniang Panlungsod of Muntinlupa this 23rd day of April, 2012 on its 74th Regular Session.
