#### **RESOLUTION NO. 12-192**

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ALDRIN L. SAN PEDRO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH BARANGAY SUCAT, MUNTINLUPA CITY IN THE TRANSFER OF THE FIVE MILLION PESOS (PHP5,000,000.00) FINANCIAL ASSISTANCE EXTENDED BY THE HON. SENATOR MANUEL B. VILLAR INTENDED FOR THE CLEARING/REMOVAL OF INFORMAL SETTLERS LOCATED AT BAGUMBAYAN CREEK, SUCAT, MUNTINLUPA CITY.

WHEREAS, Chapter 3, Article 1, Section 455 (b) (I) (vi) of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that, "the City Mayor, as the Chief Executive of the City Government shall, "represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligation, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance.";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned";

WHEREAS, on March 16, 2012 the Hon. City Mayor Aldrin L. San Pedro wrote to Hon. Senator Manuel B. Villar acknowledging the Five Million Pesos (Php5,000,000.00) delivered by the Office of Senator Manuel B. Villar to the City Treasurer of the City of Muntinlupa for the benefit of the residents of Creekside Homeowners Association now occupying the Sucat-Bagumbayan Creek, Barangay Sucat, Muntinlupa City;

WHEREAS, in same communication, the City Mayor requested that the same financial assistance be transferred and its custody as well as the duty and responsibility to distribute it to the intended beneficiaries be delegated to the Office of the Barangay Treasurer of Barangay Sucat, City of Muntinlupa;

WHEREAS, on April 23, 2012, the Office of the Hon. Manuel B. Villar, through its Chief of Staff Caroline G. Cadelina, responded positively to the request, and the dispositive portion of the said letter is quoted hereunder;

"We would like to inform your good office that we have no objection with regard to your request that the custody of the said fund and the responsibility to distribute it to the intended beneficiaries be transferred to the Barangay Treasurer of Barangay Sucat, City of Muntinlupa."

However, we recommend that a Memorandum of Agreement (MOA) be made among the parties/offices concerned to delineate the obligations related to the aforementioned fund."

WHEREAS, the amount of *Five Million Pesos (Php5,000,000.00)* financial grant will benefit *One Hundred Fifty Seven (157)* families in their relocation and transfer to settlement areas;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Hon. Aldrin L. San Pedro to enter into a Memorandum of Agreement (MOA) with Barangay Sucat, Muntinlupa City in the transfer of the Five Million Pesos (Php5,000,000.00) financial assistance extended by the Hon. Senator Manuel B. Villar intended for the clearing/removal of informal settlers located at Bagumbayan Creek, Sucat, Muntinlupa City.

ADOPTED, by the 6<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 14 day of May, 2012, on its 77<sup>th</sup> Regular Session.
