A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ALDRIN L. SAN PEDRO TO ENTER INTO A CONTRACT FOR AND IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) RELATIVE TO THE RELEASE OF THE THREE MILLION PESOS (Php3,000,000.00) FINANCIAL ASSISTANCE FOR THE AFFECTED FAMILIES AT PUROK 6, CREEKSIDE, BARANGAY SUCAT, MUNTINLUPA CITY.

WHEREAS, Chapter 3, Article 1, Section 455 (b) (l) (vi) of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that, "the City Mayor, as the Chief Executive of the City Government shall, "represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligation, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance.";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned";

WHEREAS, the DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) is tasked to undertake the implementation of the rehabilitation/construction of slope protection and desilting of Sucat-Bagumbayan Creek Project located at Barangay Sucat, Muntinlupa City, which completion rests on the fast clearing of informal settlers/structures found therein;

WHEREAS, there are 106 families residing along the creekside of Purok 6, Barangay Sucat, Muntinlupa City which has to be relocated and transferred pursuant to the provision of Republic Act 7279 which likewise mandates the local government unit as its implementing arm;

WHEREAS, the DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) has set aside the amount of *Three Million Pesos (Php3,000,000.00)* the City of Muntinlupa impose upon itself the obligation to undertake the clearing and removal of affected settlers and structures along the easement of Sucat-Bagumbayan Creed;

WHEREAS, there is a need to execute a Memorandum of Agreement (MOA) by and the City Government of Muntinlupa and the DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) so that the said amount may be released and its purpose may be served;

WHEREAS, the power of the local Chief Executive to enter into a contractual obligation is vested unto him by virtue of the Local Government Code more specifically Section 45 of Republic Act 7160;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Hon. Aldrin L. San Pedro to enter into a Contract for and in behalf of the City Government of Muntinlupa with Department of Public Works and Highways (DPWH) relative to the release of the Three Million Pesos (3,000,000.00) financial assistance for the affected families at Purok 6, Bagumbayan-Sucat Creekside located at Barangay Sucat, Muntinlupa City.

RESOLVE FINALLY, by the 6th Sangguniang Panlungsod of Muntinlupa, that a notarized copy of the **Memorandum of Agreement (MOA)** subject of this legislative act be made an integral part of this Resolution.

ADOPTED, by the 6th Sangguniang Panlungsod of Muntinlupa this 4th day of June, 2012, on its 78th Regular Session.
