A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ALDRIN L. SAN PEDRO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH BARANGAY SUCAT, MUNTINLUPA CITY IN THE TRANSFER OF THE THREE MILLION PESOS (PHP3,000,000.00) FINANCIAL ASSISTANCE EXTENDED BY THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) INTENDED FOR THE CLEARING/REMOVAL OF INFORMAL SETTLERS AT BAGUMBAYAN-SUCAT CREEK LOCATED AT BARANGAY SUCAT, MUNTINLUPA CITY.

WHEREAS, Chapter 3, Article 1, Section 455 (b) (l) (vi) of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that, "the City Mayor, as the Chief Executive of the City Government shall, "represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligation, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance.";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned";

WHEREAS, the City Government of Muntinlupa agrees to undertake the clearing and removal of the structures that will be affected by the rehabilitation/construction of slope protection and desilting of Sucat -Bagumbayan Creek project of Barangay Sucat, Muntinlupa Ciuty;

WHEREAS, the Department of Public Works and Highways (DPWH) agrees to turn over to the City Government of Muntinlupa the amount of Three Million Pesos (Php3,000,000.00) as payment of financial assistance for the on€ hundere six (106) affected families;

WHEREAS, the City Mayor requested that the same financial assistance be transferred and its custody as well as the duty and responsibility to distribute it to the intended beneficiaries be delegated to the Office of the Barangay Treasurer of Barangay Sucat, City of Muntinlupa;

WHEREAS, the amount of *Three Million Pesos (Php3,000,000.00)* financial grant will benefit *One Hundred Six (106)* families in their relocation and transfer to settlement areas;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Hon. Aldrin L. San Pedro to enter into a Memorandum of Agreement (MOA) with Barangay Sucat, Muntinlupa City in the transfer of the Three Million Pesos (Php3,000,000.00) financial assistance extended by the Department of Public Works and Highways (DPWH) intended for the clearing/removal of informal settlers at Bagumbayan-Sucat Creek, located at Barangay Sucat, Muntinlupa City.
