RESOLUTION NO. 12-199

A RESOLUTION EXPRESSING WILLINGNESS OF THE CITY GOVERNMENT OF MUNTINLUPA TO PARTICIPATE IN THE IMPLEMENTATION OF THE NATIONAL HEALTH INSURANCE PROGRAM (NHIP), THROUGH THE PARTIAL SUBSIDY SCHEME, AND AUTHORIZING THE HON. ALDRIN L. SAN PEDRO, MAYOR OF THE CITY OF MUNTINLUPA, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH).

WHEREAS, Section 11, Article XIII, of the 1987 Philippine Constitution declares that "the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged sick, elderly, disabled, women and children. The State shall endeavor to provide free medical care to paupers.";

WHEREAS, to implement the aforementioned provision, the Philippine Congress enacted Republic Act No. 7875, as amended by Republic Act No. 9241, known as "an act instituting a National Health Insurance Program (NHIP) and establishing the Philippine Health Insurance Program (PHILHEALTH) for this purpose;

WHEREAS, the National Health Insurance Program (NHIP) provides a mechanism to grant membership to low income families through sponsorship with the Local Government Units (LGUs). It will enable them access to medical services in all NHIP-accredited provides;

WHEREAS, Section 29 (t), Rule IV of the Implementing Rules and Regulations of Republic Act No. 7875, as amended by Republic Act 9241, provides that, "the partial subsidy scheme may be adopted for indigents who are proposed to be enrolled by the LGU or premium donor/s, but do not qualify for full subsidy under the means test rule xxx";

WHEREAS, the City Government of Muntinlupa considering the beneficial features of Republic Act No. 7875, as amended by Republic Act No. 9241, will vastly improve the over-all health status of the population, and ultimately, their general quality of life and rationalize the City Government's expenditure for health, collectively agreed to adopt the National Health Insurance Program (NHIP) of the National Government;

WHEREAS, the City Government of Muntinlupa, through the Hon. Aldrin L. San Pedro, Mayor of the City of Muntinlupa and the Hon. Members of the Sangguniang Panlungsod of the City of Muntinlupa, commits and agrees to shoulder the amount needed to cover the property identified indigent families in the city;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the City Government of Muntinlupa, hereby adopts the National Health Insurance Program (NHIP) of the National Government and its Implementing Rules and Regulations for In-Patient and Out-Patient Services to cover the property identified indigent families in the city.

RESOLVED THAT, the 6th Sangguniang Panlungsod of the City of Muntinlupa hereby authorizes the **Hon. Aldrin L. San Pedro**, Mayor of the City of Muntinlupa, to enter into and sign an agreement with the **Philippine Health Insurance Corporation**, represented by its President and **Chief Executive Officer, Dr. Eduardo P. Banzon**, adopting the NHIP of the National Government and provide health care services to the property identified indigent families in the city.

RESOLVED FURTHER THAT, the 6th **Sangguniang Panlungsod** of the City of Muntinlupa shall cause the enactment of an ordinance allocating funds from the appropriation for health services to finance the premium contributions of its property identified indigent families.

RESOLVED, FINALLY, THAT, a copy of this Resolution be furnished to **His Excellency Benigno S. Aquino III**, President of the Republic of the Philippines and to **Dr. Eduardo P. Banzon**, President and Chief Executive Officer of the Philippine Health Insurance Corporation (PHILHEALTH), for their information and reference.

ADOPTED, by the 6th **Sangguniang Panlungsod of Muntinlupa** this 1st day of **June 2012**, on its **79th Regular Session**.
