RESOLUTION NO. 12-204

A RESOLUTION RATIFYING THE CONTRACT AGREEMENT ENTERED INTO BY THE CITY MAYOR IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH SYSTEM AND PLAN INTEGRATOR AND DEVELOPMENT CORPORATION (SPDIC) FOR THE UPGRADE OF THE COMPUTER EQUIPMENT, PERIPHERALS, COMMERCIAL SOFTWARE AND ACQUISITION OF READY DEVELOPED APPLICATION SOFTWARE OF BUSINESS PERMIT AND LICENSING TAX ADMINISTRATION SYSTEM (BPLTAS), REAL PROPERTY TAX ADMINISTRATION SYSTEM (RPTAS), TREASURY OPERATION AND INFORMATION MANAGEMENT SYSTEM (TOIMS), GOVERNMENT APPROPRIATION AND ACCOUNTING MANAGEMENT SYSTEM (GAAMS), AND INTEGRATED GEOGRAPHIC INFORMATION SYSTEM (I-GIS) LATEST VERSIONS WITH RELATED TECHNICAL SERVICE FOR IMPLEMENTATION AND PROJECT MANAGEMENT.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, **"the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"**;

WHEREAS, City Mayor **Hon. Aldrin L. San Pedro** submitted to the Sangguniang Panlungsod the Contract Agreement entered into by the City Mayor in behalf of the City Government of Muntinlupa with System and Plan Integrator and Development Corporation (SPDIC) for the upgrade of the computer equipment, peripherals, commercial software and acquisition of ready developed application software of BPLTAS, RPTAS, TOIMS, GAAMS, AND I-GIS latest versions with related technical service for implementation and project management for approval by the City Council;

WHEREAS, the said contract is for the proposed upgrading existing computer equipment, peripherals, commercial software and application software to make the city abreast with the newest technology and address the current needs of the Local Government of Muntinlupa and in compliance with new MEMO Circulars of the National Agencies and Laws and Ordinances of the local government unit.

WHEREAS, the 6th Sangguniang Panglungsod approved Ordinance No. 12-060, entitled, *“An ordinance approving the Supplemental Budget No. 1 in the amount of Thirty Seven Million Pesos (Php37,000,000.00) to be taken from the loan from Development Bank of the Philippines (DBP)”*.

WHEREAS, the Local Government of Muntinlupa started its computerization project in 1991 for the delivery of computer equipment, peripherals, commercial software and application software such as BPLTAS, RPTS, Treasury Collection System, Police Clearance and Personnel Management & Payroll System.

WHEREAS, the Local Government of Muntinlupa published an invitation to apply and to bid with the PhilGEPS on March 2, 2012 to March 9, 2012 and the Manila Times on February 24, 2012 and March 2, 2012 for the procurement of the project;

WHEREAS, several prospective bidders who are already accredited by the LGU inquired with the BAC on the Terms of Reference, however only SPIDC submitted its letter of intent, Eligibility documents, Technical Bid and Financial Bid to the Bids and Awards Committee and was found to have passed all the requirements to be eligible to supply and bid;

WHEREAS, the total cost of the project amounts to Thirty Six Million Four Hundred Seventy Three Thousand Seven Hundred Pesos and Eleven Centavos (Php36,473,700.11);

WHEREAS, there was only one bidder who submitted a Letter of Intent (LOI), which is the Systems and Plan Integrator & Development Corporation (SPIDC).

WHEREAS, the BAC consulted the Commission On Audit (COA) regarding the lone bidder, the COA made the following recommendation based on the Revised Implementing Rules and Regulations of Republic Act 9184 stated as follows:

“Section 36. Single Calculated/Rated and Responsive Bid shall be considered for award if it falls under any of the following circumstances:

- a) ***If after advertisement, only one bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements;***
- b) ***If after advertisement, more than one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, but only one bidder meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or***

c) If after the eligibility check, more than one bidder meets the eligibility requirements, but only one bidder submits a bid, and its bid is found to be responsive to the bidding requirements.

In all instances, the procuring entity shall ensure that letters a,b,c reflects the most advantageous prevailing price for the government."

WHEREAS, the project prevailing price given by the contractor is reasonable and most advantageous to the city;

WHEREAS, the winning bidder promised to perform and comply with all the requirements and deliver the best service for the city;

WHEREAS, there is available fund to be taken from the loan from the Development Bank of the Philippines (DBP) loan amounting to *Thirty Seven Million Pesos (Php37,000,000.00)*;

NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod of Muntinlupa, to ratify the **Contract Agreement entered into by the City Mayor in behalf of the City Government of Muntinlupa with **System and Plan Integrator and Development Corporation (SPDIC)** for the upgrade of the computer equipment, peripherals, commercial software and acquisition of ready developed application software of **Business Permit and Licensing Tax Administration System (BPLTAS), Real Property Tax Administration System (RPTAS), Treasury Operation and Information Management System (TOIMS), Government Appropriation and Accounting Management System (GAAMS), and Integrated Geographic Information system (I-GIS)** latest versions with related technical service for implementation and project management.**

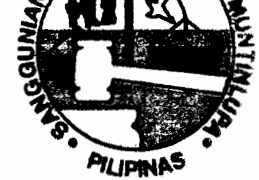



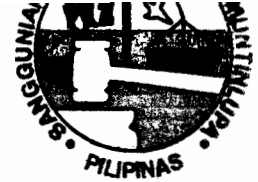
