The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed”;

WHEREAS, to comply with the Civil Service Commission Qualification Standard the City Mayor Hon. Aldrin L. San Pedro, endorsed the appointment of **DR. RAQUEL P. TOLENTINO** to the City Council for confirmation;

WHEREAS, **DR. RAQUEL P. TOLENTINO**, was appointed as Temporary Department Head II in 2009, there is a need two (2) years to complete the five (5) years experience as Department Head II, for her to comply the Civil Service Commission qualification standard;
