WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

**WHEREAS**, the contract of lease between the City Government of Muntinlupa and Joseph A. Villalon, Attorney In Fact, is for the use of 1<sup>st</sup> and 2<sup>nd</sup> Floors of Norfil Building presently being occupied by the Grade 7 (First Year Students) of Muntinlupa National High School (MNHS) Annex;

WHEREAS, the monthly rental of the leased premises shall be at the rate of Seventy Thousand Pesos (Php70,000.00). The lease contract shall be for the period of one year and shall commence on May 1, 2012 up to May 1, 2013;

WHEREAS, the lease premises will be used as classrooms for first year or Grade 7 with 230 students and seven (7) teachers. The building is divided in five classrooms, one administrative office and one faculty room;

WHEREAS, the said space is being used by the Muntinlupa National High School Tunasan Annex since May 1, 2012;

WHEREAS, as certified by the Budget Officer there is an available fund for the said purpose under the General Fund 2012 Executive Budget;
