RESOLUTION NO. 12-211

A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH AM-FM BUILDERS FOR PROJECT STREET LIGHTING AT SOUTH EXPRESSWAY EXIT TO CORNER MONTILLANO LOCATED AT BARANGAY ALABANG, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION TWO HUNDRED TWENTY SIX THOUSAND FIVE HUNDRED SEVENTY ONE PESOS AND 71/100 (PHP1,226,571.71) WHICH AMOUNT SHALL BE TAKEN UNDER THE 20% COMMUNITY DEVELOPMENT FUND (CDF)-2012 EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(vii) of the Local Government Code of 1991, provides that, "the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, on May 7, 2012, the 6th Sangguniang Panlungsod approved *Ordinance No. 12-066*, for allocation of budget for the proposed project by the city government;

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the Construction Agreement for ratification;

WHEREAS, the STREET LIGHTING AT SOUTH EXPRESSWAY EXIT TO CORNER MONTILLANO located at Barangay Alabang, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, the City Government of Muntinlupa entered into Construction Agreement with AM-FM BUILDERS for the STREET LIGHTING AT BPI TO SOUTH EXPRESSWAY EXIT TO CORNER MONTILLANO amounting to ONE MILLION TWO HUNDRED TWENTY SIX THOUSAND FIVE HUNDRED SEVENTY ONE PESOS AND 71/100 (PHP1,226,571.71) as a result of a public bidding held on May 3, 2012;


