A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH AM-FM BUILDERS FOR PROJECT STREET LIGHTING AT SOUTH EXPRESSWAY EXIT TO CORNER MONTILLANO LOCATED AT BARANGAY ALABANG, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION TWO HUNDRED TWENTY SIX THOUSAND FIVE HUNDRED SEVENTY ONE PESOS AND 71/100 (PHP1,226,571.71) WHICH AMOUNT SHALL BE TAKEN UNDER THE 20% COMMUNITY DEVELOPMENT FUND (CDF)-2012 EXECUTIVE BUDGET.

WHEREAS, the **STREET LIGHTING AT SOUTH EXPRESSWAY EXIT TO CORNER MONTILLANO** located at Barangay Alabang, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

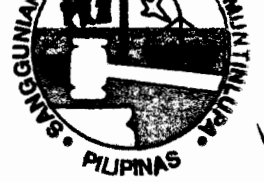
