A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO. IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH ASRO CONSTRUCTION & TRADING FOR UPGRADING OF CLASSROOM WINDOWS & FACILITIES AT PEDRO E. DIAZ HIGH SCHOOL (PEDHS) LOCATED AT BARANGAY ALABANG, MUNTINLUPA CITY IN THE AMOUNT OF THREE MILLION FIVE HUNDRED FIFTY THREE THOUSAND TWO HUNDRED EIGHTY SEVEN PESOS AND 76/100 (PHP3,553,287.76) WHICH AMOUNT SHALL BE TAKEN UNDER THE SCHOOL BOARD FUND-2012 EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, on May 7, 2012, the 6th Sangguniang Panlungsod approved Ordinance No. 12-063, for allocation of budget for the proposed project by the city government;

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the Construction Agreement for ratification;

WHEREAS, the Upgrading Of Classroom Windows & Facilities located at Pedro E. Diaz High School, Barangay Alabang, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on May 21,2012, the City Government of Muntinlupa entered € into Construction Agreement with ASRO Construction & Trading for the Upgrading Of Classroom Windows & Facilities amounting to Three Million Five Hundred Fifty Three Thousand Two Hundred Eighty Seven Pesos And 76/100 (Php3,553,287.76) as a result of a public bidding held on May 23, 2012;

WHEREAS, the Construction Agreement in consideration of the payments to be made by the City Government to ASRO Construction & Trading as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on May 7, 2012, the Bids and Awards Committee (BAC) approved Resolution No. 12-0003, "declaring the Asro Construction & Trading as the bidder with the Lowest Calculated Responsive Bid for the Upgrading Of Classroom Windows & Facilities located at Pedro E. Diaz High School, Barangay Alabang, Muntinlupa City and recommend the approval by the City Mayor;

WHEREAS, pursuant to the *Supreme Court* (SC) decision, there is a need for the Sangguniang Panlungsod *to ratify* contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro, in behalf of the City Government of Muntinlupa with ASRO Construction & Trading for Upgrading Of Classroom Windows & Facilities located at Pedro E. Diaz High School, Barangay Alabang, Muntinlupa City, in the amount of Three Million Five Hundred Fifty Three Thousand Two Hundred Eighty Seven Pesos And 76/100 (Php3,553,287.76) which amount shall be taken under the School Board Fund - 2012 Executive Budget.
