#### **RESOLUTION NO. 12-216**

A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH PDJ INTEGRATED CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF CHB CANAL LOCATED AT ALONG PNR, BARANGAY BULI, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION FIVE HUNDRED FIFTY TWO THOUSAND FOUR HUNDRED TWENTY SIX PESOS AND 58/100 (PHP1,552,426.58) WHICH AMOUNT SHALL BE TAKEN UNDER THE 20% COMMUNITY DEVELOPMENT FUND-2012 EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, on February 29, 2012, the 6th Sangguniang Panlungsod approved Ordinance No. 12-054, for allocation of budget for the proposed project by the city government;

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the Construction Agreement for ratification;

WHEREAS, the construction of CHB canal located at Along PNR, Barangay Buli, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on May 21,2012, the City Government of Muntinlupa entered into Construction Agreement with PDJ Integrated Construction for the CONSTRUCTION OF CHB CANAL amounting to One Million Five Hundred Fifty Two Thousand Four Hundred Twenty Six Pesos And 58/100 (Php1,552,426.58) as a result of a public bidding held on March 23, 2012;

WHEREAS, the Construction Agreement in consideration of the payments to be made by the City Government to PDJ Integrated Construction as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on March 24, 2012, the Bids and Awards Committee (BAC) approved Resolution No. 12-0002, "declaring the PDJ Integrated Construction as the bidder with the Lowest Calculated Responsive Bid for the construction of CHB canal located at Along PNR, Barangay Buli, Muntinlupa City and recommend the approval by the City Mayor;

**WHEREAS,** pursuant to the *Supreme Court* (SC) decision, there is a need for the Sangguniang Panlungsod *to ratify* contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6<sup>th</sup> Sangguniang Panlungsod to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro, in behalf of the City Government of Muntinlupa with PDJ Integrated Construction for the project construction of CHB canal located at Along PNR, Barangay Buli, Muntinlupa City, in the amount of One Million Five Hundred Fifty Two Thousand Four Hundred Twenty Six Pesos and 58/100 (Php1,552,426.58) which amount shall be taken under the Community Development Fund - 2012 Executive Budget.
