SAN PEDRO FOR THE PERIOD 01 JANUARY TO 30 APRIL 2012, UNDER THE SAME TERMS AND CONDITIONS OF THE ORIGINAL CONTRACT IN THE AMOUNT OF FOURTEEN MILLION (PHP14,000,000.00) PESOS PER MONTH.**

**WHEREAS**, the City Mayor Hon. Aldrin L. San Pedro seeks to secure the grant of authority from the Sangguniang Panlungsod of Muntinlupa, as legislative body, to extend the City Government's Contract with Expedition Corporation for the garbage hauling and disposal services within the territorial jurisdiction of the City of Muntinlupa;

**WHEREAS**, Section 22 (c) of Republic Act 7160, otherwise known as the Local Government Code of 1991, states that, **"every local government unit, as a corporate shall xxx unless otherwise provided in this Code, no contract maybe entered into by the local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned"**;

**WHEREAS**, the extension of ongoing contracts of general supports services is allowed for the purpose of averting cessation in the delivery of services essential, indispensable and necessary in the operations of a procuring entity;

**WHEREAS**, the contract extension is imperative to maintain the cleanliness of the entire city, to prevent the breakdown in sanitation, and to ensure the health and well being of the people of Muntinlupa;

**WHEREAS**, the contract extension is undertaken due to circumstances beyond the procuring entity's control and it cannot award a new contract within a month after the expiration of the term of the original contract;

WHEREAS, the Bid and Awards Committee (BAC) of the City approved BAC Resolution Numbers 2012-001-001 and 2012-001-002, recommending the approval of the extension of contract of the City Government with Expedition Corporation for garbage hauling and disposal services, under the same terms and conditions of the original contract at a contract price of **Fourteen Million Pesos (Php14,000,000.00)** per month;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to confirm and ratify the extension of contract of **Expedition Corporation** for the Garbage Hauling and Disposal Services with the City Government of Muntinlupa through the **Hon. City Mayor Aldrin L. San Pedro** for the period **01 January to 30 April 2012**, under the same Terms and Conditions of the original Contract in the amount of **Fourteen Million (Php14,000,000.00) Pesos** per month.






