WHEREAS, Article 86 (b) (I) (vi) and Article 86 (b)(I)(viii) of the Local Government Code of 1991 provides that, "the city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances;"

WHEREAS, the Hon. City Mayor Aldrin L. San Pedro, wrote a letter to Philippine Long Distance Telephone Company (PLDT) requesting for an upgrade on connection capabilities of the existing telephone system in the City Hall of Muntinlupa as the telecommunication infrastructure needs to be regularly proven at par with the ever changing and dynamic environment in furtherance of addressing the public welfare;

WHEREAS, in a letter dated 28 August 2012, PLDT, through its Government Relation Officer, Juan S. Alonzo IV, wrote a letter to the City Mayor Hon. Aldrin L. San Pedro its proposal for PLDT VOX, one of the company's Business Solutions Services, for installation in the City Hall of Muntinlupa;

WHEREAS, the letter above-referred to includes a Quotation for the City Government of Muntinluap, dated 14 August 2012, tabulating the monthly estimated rental, non-recurring Service Connection Changes (SCC) and City Electrician Inspection Fee (CEIF) of the said system;

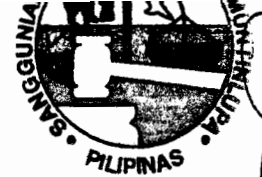

WHEREAS, the Agreement to Lease covers a period of Sixty (60) months or five (5) years and involves the amount of Two Hundred Sixty Three Thousand Four Hundred Forty Five Pesos and Thirty Two Centavos (Php263,445.32);

WHEREAS, the Agreement to Lease likewise provides that, in case of pre-termination, the City Government shall pay the total remaining balance of the unpaid portion of the period, computed as months left multiplied by the monthly lease fee; that the monthly rental is subject to National Telecommunications Commission (NTC) approved currency adjustment; and that comprehensive maintenance during the period of the agreement shall be included;

WHEREAS, the Agreement to Lease, providing all in detail the Bundled PLDT Trunk Lines and VOX Terms and Conditions, is hereto attached and made an integral part of this resolution;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **6th Sangguniang Panlungsod of Muntinlupa**, to authorize the **Hon. City Mayor Aldrin L. San Pedro**, in behalf of the City Government of Muntinlupa to sign the **Agreement to Lease** between the **Philippine Long Distance Telephone (PLDT)** Company for the installation of a Voice Telephony System or PABX Equipment, including service and maintenance thereof.

ADOPTED, by the **6th Sangguniang Panlungsod of Muntinlupa**, this **15th** day of **October 2012**, on its **95th Regular Session**.
