SAN PEDRO TO SIGN FOR IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE NATIONAL STATISTICS OFFICE – OFFICE OF THE CIVIL REGISTRAR GENERAL (NSO-OCRG) AS REPRESENTED BY ITS REGIONAL DIRECTOR LOURDES V. HOMECILLO THE NEW AND UPDATED SOFTWARE PHILIPPINE CIVIL REGISTRY INFORMATION SYSTEM (PhilCRIS).

WHEREAS, Article 86 (b)(1)(vi) and Article 86¹ (b)(1)(viii) of the Local Government Code of 1991, provides that, ***“the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”***;

WHEREAS, Section 22 (c), of the same Code, states that, ***“unless provided in this Code, no contract maybe entered into by the local chief executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned”***;

WHEREAS, on **03 August 2012**, the City Mayor Hon. Aldrin L. San Pedro, endorsed to the Sangguniang Panlungsod the Memorandum of Agreement between the National Statistics Office-Office of the Civil Registrar General and the City Governmen of Muntinlupa on the new updated software Philippine Civil Registry Information System (PhilCRIS);

WHEREAS, on **10 October 2012** the Committee on Information Technology conducted a public hearing on the said Memorandum of Agreement;

WHEREAS, the delivery of Civil Registry services should be simplified and streamlined in support of the good governance policy of the administration;

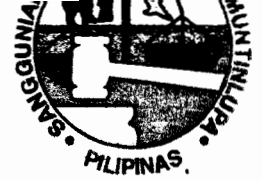

WHEREAS, the National Statistics Office (NSO) has developed an updated software Philippine Civil Registry Information System (PhilCRIS) to deliver civil registry information management in a new, more user, friendly and efficient way;

WHEREAS, the PhilCRIS is a software in windows version of the Civil Registry Information System (CRIS DOS version) which enables encoding of relevant information from civil registry documents, storage of vital data, query and retrieval of encoded records, printing and issuance of certified copies of encoded civil registry documents, generation of transmittal files, data management and maintenance of the local civil registry database;

WHEREAS, in entering this agreement, the Local Government of Muntinlupa is given authorization to use the PhilCRIS **free-of-charge** in accordance with the rules and regulations set out for its purpose;

WHEREAS, the National Statistics Office (NSO) shall provide the complete set of parameters required to install the PhilCRIS software;

WHEREAS, the National Statistics Office (NSO) shall also provide technical support to the Local Government subject to the provisions of warranties of NSO which includes but not limited to, assistance in the installation of the PhilCRIS software, trouble shooting PhilCRIS software and database problems, and provision of software patches and upgrades to the PhilCRIS software. But excludes troubleshooting computer hardware problems and installing and configuring operating systems;

WHEREAS, the City Government has to provide all relevant computer hardware and software environment, including protection from viruses, necessary to be able to use the PhilCRIS software;

WHEREAS, the local government thru the Local Civil Registry Office shall coordinate closely with the National Statistics Office (NSO) Provincial Statistics Office on the proper operation and use of the system and send a copy of encoded civil registry records to the NSO-PSO within the first ten (10) days of the reference month;

WHEREAS, by this new software the Local Civil Registrar Office can guarantee good, fast and effective services, given to the constituents of Muntinlupa;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th **Sangguniang Panlungsod of Muntinlupa**, to authorize the City Mayor **Hon. Aldrin L. San Pedro** to sign for in behalf of the City Government of Muntinlupa the **Memorandum of Agreement (MOA)** between the **National Statistics Office – Office of the Civil Registrar General (NSO-OCRG)** as represented by its **Regional Director Lourdes V. Homecillo**, the new and updated **Software Philippine Civil Registry Information System (PhilCRIS)**.

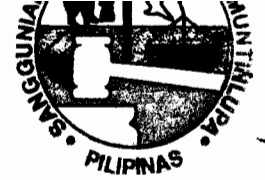


