A RESOLUTION APPROVING THE CONVERSION OF LAKEVIEW ELEMENTARY SCHOOL INTO LAKEVIEW INTEGRATED SCHOOL AS A REQUIREMENT OF THE DEPARTMENT OF EDUCATION.

WHEREAS, Section 17, Article 11 of 1987 Constitution provides that, **"the state shall give priority to education, science and technology, arts, culture and sports to poster patriotism and nationalism, accelerate social progress to promote total human liberation and development"**;

WHEREAS, Lakeview Elementary School located in Barangay Putatan, Muntinlupa City was established 1972 to cater to the needs of our growing student population in District I;

WHEREAS, there is a need to convert the Lakeview Integrated School to accommodate both elementary and high school students in one school and the caters to the growing needs of the city for additional secondary schools;

WHEREAS, a City Council Resolution is one of the requirements for the final approval by the Department of Education of the proposed conversion of Lakeview Elementary School into Lakeview Integrated School.

WHEREAS, the following reasons were cited for the conversion:

- a) **Enrollment of the school is maintained at its lowest rate, if not declining year after year. The student population of Lakeview Elementary School was 1,200 (grades 1 to 6); when it was converted into an annex (known as Lakeview Elementary School - PEDHS Annex) this school year 2012, the enrolment increased to 1,606 students due to the addition of Grade 7 (equivalent to first year high school) with four new sections (199 students) and the kinder class (200 pupils);**

- b) *Classrooms are now being constructed by the Department of Education to accommodate the high school enrollees. At present there are 18 classrooms in three buildings. A new school building is being constructed to create additional classrooms;*
- c) *The school has the space to accommodate both the elementary and high school students. Lakeview Elementary School lot is the only school owned by the Department of Education with a total area of 14,000 square meters more or less, but only 6,000 square meters is occupied by the school. The remaining space is occupied by informal settlers;*
- d) *There is no public high school in Barangay Putatan area.*
- e) *This will decongest Pedro E. Diaz High School (PEDHS) and Muntinlupa National High School (MNHS) which have 7,000 plus enrollees.*

WHEREAS, the administration, faculty and staff commit to the fulfillment of the vision and mission of the **Department of Education** and the **City Government of Muntinlupa** in the delivery of quality and affordable basic education to its constituents;

WHEREAS, the objectives of the Lakeview Integrated School are the following:

- a) *Accessibility for the graduates of the elementary (grade six);*
- b) *Usage of the school facilities to the utmost;*
- c) *Creation of mutual ties for program development and professional development;*
- d) *Availability of flexible resources to address needs of the learners;*
- e) *Minimal expenditures for parents since the school is very near their houses;*
- f) *Save on school buildings on the part of Department of Education;*
- g) *Caters to the K-12 curriculum;*
- h) *Unified management and governance methods in governing the whole school system;*

WHEREAS, the concept of establishing an integrated school is through the recommendation of **Dr. Dominico C. Idanan**, the Officer-In-Charge of the Schools Division Superintendent;

WHEREA, in the **Division of Muntinlupa** there is no public integrated school that has ever been established;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **6th Sangguniang Panlungsod of Muntinlupa**, to approve the conversion of Lakeview Elementary School into Lakeview Integrated School as requirement of the Department of Education (DepEd).

ADOPTED, by the **6th Sangguniang Panlungsod of Muntinlupa** this **22nd** day of **October** of **2012**, on its **96th** Regular Session.
