AN ORDINANCE APPROPRIATING THE AMOUNT OF SIX HUNDRED TEN THOUSAND PESOS (PH610,000.00) FOR FAMILIES AFFECTED BY THE FIRE ON FEBRUARY 5, 2013 AT WEST KABULUSAN 1A & 1B, BARANGAY CUPANG, MUNTINLUPA CITY WHICH AMOUNT SHALL BE TAKEN FROM THE 2013 EXECUTIVE BUDGET UNDER THE CALAMITY FUND.

WHEREAS, Section 458 (a)(l)(iv), of the Local Government Code of 1991 states that, *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxxx and appropriate funds for the general welfare of the city and its inhabitants xxx, and"*:

(l)(iv) shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, as reported by the Social Welfare and Development Office (SWDO) on **February 08, 2013**, there were **eighty eight (88)** families were affected by the fire in **West Kabulusan IA and IB, Barangay Cupang, Muntinlupa City**;

WHEREAS, the owner of the houses, renters, and sharers were rendered homeless by reason of the said conflagration;

WHEREAS, the **Social Welfare and Development Office (SWDO)** recommended to declare the affected area as in **a state of calamity**;

well

WHEREAS, the 6th Sangguniang Panlungsod passed a Resolution No. 13-251, entitled, "A resolution declaring the area affected by the fire on February 5, 2013 at West Kabulusan IA and IB, Barangay Cupang, Muntinlupa City, as in a state of Calamity";

WHEREAS, the **Social Welfare and Development Office (SWDO)** of the City has submitted a certified copy of the list of the homeowners, renters, sharer (totally damaged) in coordination with the **Barangay Chairman of Cupang**, is made an integral part of this ordinance;

WHEREAS, there is a need for the City Government to give financial assistance to the aforesaid victims in the amount of **Six Hundred Ten Thousand Pesos (Ph610,000.00)** to be distributed as follows:

I. TOTALLY DAMAGED HOUSES:

a) OWNER:	30 @ 10,000	Php300,000.00
b) RENTER:	17 @ 5,000.00	85,000.00
c) SHARER:	41 @5,000.00	205,000.00
d) CASUALTY:	1 (Sandra Araos-3yrs old)	20,000.00
TOTAL AMOUNT:		Php610,000.00 =====

WHEREAS, there is an available fund from the 2013 Executive Budget under Calamity Fund of the City;

NOW THEREFORE, BE IT RESOLVE, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod duly assembled to appropriate **Six Hundred Ten Thousand Pesos (Ph610,000.00)** for families affected by the fire on February 5, 2013 at West Kabulusan 1A & 1B, Barangay Cupang, Muntinlupa City which amount shall be taken from the 2013 Executive Budget under the Calamity Fund.

ENACTED, by the 6th Sangguniang Panlungsod of Muntinlupa this 11th day of February 2013, on its **107 Regular Session**.
