WHEREAS, portions of San Guillermo, Lower Putatan, Muntinlupa City, specifically along the fault lines, *is presently submerged under water* due to heavy rainfall;

WHEREAS, a certain portion of *San Guillermo St.*, which plays a vital role in linking Putatan to other barangays of Muntinlupa *is also under flood water*;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to declare San Guillermo, Lower Putatan, Muntinlupa City *as in a State of Calamity* and to authorize the City Mayor, Hon. Jaime R. Fresnedi, for the *immediate release of calamity funds* for the following purposes:

- a) For the immediate rehabilitation of the road submerged under water,
- b) For the relief operation and other financial assistance to the affected families,
- c) Purchase of lumber and other construction materials for temporary bridge to connect houses under water to areas not affected by flood water.

ADOPTED, by the *Sangguniang Panlungsod of Muntinlupa* this 05th day of January 2000 on its 66th Regular Session.
