WHEREAS, the City of Muntinlupa *is chosen as one of the recipients* among Local Government Units (LGUs) of the DILG and Aus-AID Assisted Street and Urban Working Children Project (SUWCP);

WHEREAS, the project's goal is *to support national and local initiatives towards addressing the growing problem of street and urban working children* (SUWC) by enhancing the effectiveness of programs implemented by LGUs, NGOs and GOs that address the needs of street and urban working children;

WHEREAS, the City of Muntinlupa *has been identified as implementor* of the project by virtue of the provisions of the Local Government Code on devolution of social welfare services functions to the LGUs, people empowerment, and active participation of NGOs in local government affairs as effective partner in nation building in close coordination with the participating non-government organizations (NGOs) and government agencies (Gas);

WHEREAS, this body believes that *this project is most beneficial to the City Government of Muntinlupa*, especially in improving the delivery of social services considering the existence of 815 reported street children;

NOW, THEREFORE, BE IT RESOLVED, by the *Sangguniang Panlungsod of Muntinlupa* in session assembled, *to authorize*, as it hereby authorizes the Honorable *City Mayor to enter into and sign a Memorandum of Agreement* with the Department of Interior and Local Government relative to DILG and Aus-AID Assisted Street and Urban Working Children Project (SUWCP).


