## RESOLUTION NO. 20-178

A RESOLUTION EXTENDING/RENEWING THE CONTRACT OF THE REN TRANSPORT CORPORATION FOR THE COLLECTION OF GARBAGE FROM FEBRUARY 1, 2000 TO JULY 31, 2000 UNDER THE SAME TERMS AND CONDITIONS, EXCEPT AS TO THE PRICE WHICH SHOULD NOW BE TWENTY EIGHT MILLION EIGHT HUNDRED SEVENTY FIVE THOUSAND PESOS (P28, 875,000.00), AND AUTHORIZING MAYOR JAIME R. FRESNEDI TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT.

WHEREAS, the contract for the collection of garbage between the City Government and REN Transport Corporation expired on January 31, 2000;

WHEREAS, on January 19, 2000, the REN Transport Corporation *requested to* extend/renew the contract for the collection of garbage, thru a letter to the City Mayor, pursuant to Paragraph VIII, Sub-paragraph 8.2 of the contract, which states that:

"8.2. At the option of the OWNER and upon conformity of the contractor, the contract may be renewed."

WHEREAS, there is a need to continue the daily collection of the garbage to maintain the cleanliness of the entire city and to prevent epidemic that maybe caused by garbage if not collected;

WHEREAS, on October 21, 1999, the REN Transport Corporation *requested*, thru a letter, the City Mayor *to increase the contract price* because of increase in the price of the fuel, increase in toll fees and impending increase of the salaries of the drivers and paleros;

WHEREAS, on January 4, 2000, again the REN Transport sent another letter to the City Mayor requesting to increase the contract price by Eleven Million Seven Hundred Eighty Five Thousand Four Hundred Pesos (P11,785,400.00) (22.5% of the total contract price), due to the increase in fuel, toll fees, wages, dumping fee, maintenance (lubricants, spare parts, labor);

WHEREAS, it is a public knowledge that there were increases in fuel, toll fees, salaries; lubricants, labor and spare parts;

WHEREAS, though the City Government is aware that the contract price of the REN Transport Corporation was only *Fifty Two Million Five Hundred Thousand Pesos* (P52,500,000.00) from the budget of *Sixty Five Million Pesos* (P65,000,000.00) allocated last year, 1999, the City Council should see to it that the grant of increase should be most advantageous to the city;

WHEREAS, despite the increases in fuel, toll fees, wages, lubricants, labor and spare parts, the City Government can only grant 10% increase in the contract price or a total of Two Million Six Hundred Twenty Five Thousand Pesos (P2,625,000.00) for the extended period of six (6) months;

WHEREAS, there is a budget for the collection of garbage in the 2000 Executive Budget.

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, to extend/renew the contract of services of the REN Transport Corporation for six (6) months from February 1, 2000 to July 31, 2000 for Twenty Eight Million Eight Hundred Seventy Five Thousand Pesos (P28,875,000.00) and to authorize Mayor Jaime R. Fresnedi to sign for and in behalf of the City Government
