RESOLUTION NO. 20-218

A RESOLUTION REQUESTING THE DEPARTMENT OF JUSTICE (DOJ) TO SET ASIDE A PORTION OF THE NATIONAL BILIBID PRISON (NBP) COMPOUND FOR THE TEMPORARY RELOCATION OF THE LEGITIMATE RESIDENTS WHO WERE AFFECTED IN THE DEMOLITION OF THEIR HOUSES UNTIL A PERMANENT RELOCATION SITE IS PROVIDED.

WHEREAS, about two thousand five hundred fifty (2,550) families were affected in the demolition of their respective houses in the New Bilibid Prison Compound, Muntinlupa City, *last April 17, 2000*, without the needed prior relocation site as mandated by the RA 7279;

WHEREAS, the demolition of the residents of the National Bilibid Prison Compound was done without the consent of the City Government of Muntinlupa by the Director of the National Bilibid Prison which is under the Department of Justice;

WHEREAS, as a consequence of the demolition of their respective houses, these affected families were scattered in different places within the compound, living in extreme miserable and inhuman conditions, staying in open spaces, thus, exposed to the natural elements, and without any basic necessities of human existence;

WHEREAS, with their present deplorable and unsanitary condition, if not given by any assistance, these affected families will suffer serious illness which might ultimately result in widespread diseases and epidemic and might contaminate other residents of the City of Muntinlupa;

WHEREAS, it is imperative that these affected families must be given some form of social assistance, and be temporarily relocated so that they may be given shelter and protection;

NOW, THEREFORE, resolved as it is hereby resolved, that the Director of the National Bilibid Prison Director Sistoza, be and he is hereby requested to allocate a sufficient and specific portion of the National Bilibid Prison Compound, to be used as temporary relocation site for the legitimate and qualified affected residents, until such period as time as a permanent relocation site be found for the need of these people;


RESOLVED FURTHER, that for the best interest and general welfare of these affected families, and considering the urgency of the situation, the authorities of the National Bilibid Prison shall give this matter their most preferential attention and consideration.

RESOLVED FINALLY, that the copies of this Resolution be and the same are hereby furnished the Secretary of Justice, Manila, and the Director of the National Bilibid Prison, Muntinlupa City.

APPROVED, by the *Sangguniang Panlungsod of Muntinlupa* this 17th day of May 2000 on its 83rd Regular Session.
