AWINGAN, PMA CLASS '96 GRADUATE, WHO WAS KILLED ON MAY 25, 2000 IN AN AMBUSH BY THE MORO ISLAMIC LIBERATION FRONT ON A MISSION TO COUNTERACT THE HOSTILITY OF THE SAID GROUP IN LANAO DEL SUR, AND GIVING HIM A MEDAL OF HONOR, AND HIS HEIR, MRS. MARIA CORINA CRUZ AWINGAN, TWENTY THOUSAND PESOS (P20,000.00) AS FINANCIAL ASSISTANCE, WHICH AMOUNT SHALL BE TAKEN FROM ANY AVAILABLE FUND OF THE OFFICE OF THE CITY MAYOR.**

**WHEREAS**, *1<sup>st</sup> Lieutenant Hubert W. Awingan* and his family are residents of Estehonor Compound, Alabang, Muntinlupa City;

**WHEREAS**, *his gallantry as a soldier* that resulted to his heroic death is *worthy to emulate* as it serves as an example to all soldiers and peace-loving Filipino;

**RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED** to *recognize the gallantry of the late 1<sup>st</sup> Lieutenant Hubert W. Awingan*, a PMA Class '96 graduate, who was killed on May 25, 2000 in an ambush by the Moro Islamic Liberation Front on a mission to counteract the hostility of the said group in Lanao del Sur, and *giving him a medal of honor*, and his heir, Mrs. Maria Corina Cruz Awingan, *Twenty Thousand Pesos (P20,000.00) as financial assistance*, which amount shall be taken from any available fund of the Office of the City Mayor.




