WHEREAS, Article 14, Section 1 of the 1987 Constitution states that *"The State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all"*;

WHEREAS, more than ten thousand (10,000) people are now inhabiting the Victoria-Camella (Ridgeview) area in Barangay Tunasan;

WHEREAS, the area is approximately ten (10) kilometers away from Tunasan proper where the Tunasan Elementary School is located and is accessible only through San Pedro, Laguna;

WHEREAS, an area has been donated by the developer for the purpose of establishing a school site;

WHEREAS, there are two (2) new existing vacant houses in the said area which would serve as classrooms for Grade 1 and 2;

WHEREAS, majority of the present residents are average income earners who could hardly afford the high cost of private education;

WHEREAS, the number of children in the area who cannot afford the high cost of private education is increasingly alarming;

WHEREAS, their concerns should be addressed immediately and positively.


