SANGGUNIANG PANLUNGSOD

ORDINANCE NO. 96-62

**AN ORDINANCE INCREASING THE UNIFORM/CLOTHING ALLOWANCE OF OFFICIAL AND EMPLOYEES OF THE MUNTINLUPA CITY GOVERNMENT.**

**WHEREAS**, the General Appropriations Acts for Fiscal Year 1996, otherwise known as Republic Act No. 8174 modified the uniform/clothing allowance of the officials and employees of the local government units by increasing it to a maximum of P1,800.00 peer annum;

**WHEREAS**, pursuant to paragraph 2.2 of the Department of Budget and Management Circular No. 59, s-96, the local government units may grant uniform/clothing allowance to local government officials and employees at rates not exceeding P1,800.00 per annum subject to approval by their respective Sanggunian;

**WHEREAS**, the Sangguniang Panglungsod of Muntinlupa City, deemed it necessary to implement RA 8174 and Department of Budget and Management Circular No. 59,s-96 by increasing the yearly uniform/clothing allowance of the officials and employees of the Muntinlupa City Government from P1,500.00 to P1,800.00 per annum;

**BE IT ORDAINED, AS IT IS HEREBY ORDAINED** by the Sangguniang Panglungsod:

**SECTION 1.** All officials and employees of the City Government of Muntinlupa shall be entitled to a uniform/clothing allowance in the amount of P1,800.00 per annum.

**SECTION 2.** Said uniform/clothing allowance shall be in lieu of any similar grant, in cash or kind, of the same amount or value given to said officials and employees.

**SECTION 3.** The total amount to cover said uniform/clothing allowance shall be included in the yearly appropriation/budget of the City Government.

**SECTION 4.** All City ordinances, resolutions, rules and regulations which are inconsistent with this ordinance are deemed modified accordingly.

**SECTION 5.** This ordinance shall be suppletory to RA 8174 (General Appropriations Act of 1996) and Department of Budget and Management Circular No. 59, s-96.

**SECTION 6.** This ordinance shall take effect upon its approval.






