WHEREAS, the open spaces and roadlots in Villa Carolina I were already donated by the developer. Harvester Construction and Industrial Corporation on March 15, 1983 per Deed of Donation executed by the said company and the Municipality of Muntinlupa;

WHEREAS, some of the roads in Villa Carolina I are already destroyed and need to be repaired and cemented;

WHEREAS, one of the roads that need immediate repair / construction is the PESO Street (main road of Villa Carolina I );

WHEREAS, as per Bill of Materials submitted by the Engineering Office the budgetary cost of Two Million Pesos (P2,000,000.00) can cement a length of 322 meters, 7.50 meters in width and 0.15 in thickness;

WHEREAS, there is an amount of One Million Pesos (P1,000,000.00) in the General Fund for 1997 Executive Budget under infrastructure available for this project;

WHEREAS, there is another fund in the amount of One Million Pesos (P1,000,000.00) set aside for the continuing appropriation last year, 1996 intended for the Alabang Viaduct Drainage system which amount will no longer be used for the project as Manuela Corporation has funded it;

WHEREAS, the One Million Pesos (P1,000,000.00) under Request for Obligation of Allotment No. 101-9606-271 which is reverted to the General Fund for 1997 can be set aside as additional fund for the road concreting of the PESO St. in Villa Carolina I.

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Panglungsod that the amount of Two Million Pesos (P2,000,000.00) be set aside/allocated for the road concreting of the PESO St. in Villa Carolina I, Tunasan, Muntinlupa City.
