WHEREAS, Section 19 of Republic Act No. 7796, otherwise known as the Technical Education and Skills Development Authority (TESDA) Act of 1994, provides for the establishment of Technical Education and Skills Development Committees (TESDCs) at the regional and local levels to coordinate and monitor the delivery of all skills development activities by the public and private sectors:

WHEREAS, to fully realize a functional partnership between the public and private sectors, the TESDA law further stipulates the creation of TESD Committees at the regional and local levels:

WHEREAS, there is a need to create a TESDC at the City level to provide relevant, accessible, high quality and effective technical education and skills development in support of the development of quality and competitive middle level manpower responsive to and in accordance with the country's development goals and priorities:

WHEREAS, the TESDC shall coordinate and monitor the delivery of skill development activities by the public and private sectors and provide advisory support to the Local Development Council:

WHEREAS, the organization of the TESDC aims to rationalize allocation of resources in meeting the demands on technical education and skills development:

NOW, THEREFORE, BE IT ORDAINED, by the Sangguniang Panglungsod of Muntinlupa in session assembled that :

Section I. The Technical Education and Skills Development Committee of the City of Muntinlupa is hereby created.

Section 2. **Composition of the Committee** - The Technical, Education and Skills Development shall be composed of the following :

- 2.1 The City Mayor
- 2.2 The TESDA District Director
- 2.3 A Representative from the labor sector
- 2.4 A Representative from the employer sector
- 2.5 A Representative from Technical, Vocational Education and Training (TVET) Sector

The Committee members shall elect from among themselves the Chairperson and Vice-Chairperson whose terms shall not be more than one (1) year.

Section 3. **Function of the Committee** :

- 3.1 Assess technical, vocational education and skills development needs and TVET capacity in the city;
- 3.2 Update on a periodic basis the profile of TVET institutions;
- 3.3 Recommend program proposals including the annual agency plans of the public TVET institutions, and recommend allocation of resources to such programs/plans to the regional TESD Committee, as the case maybe;
- 3.4 Provide technical expertise/support to the Local Development Council on technical education and skills development matters;
- 3.5 Provide policy inputs to the Regional TESD Committee, as the case may be;
- 3.6 Coordinate program implementation and prepare annual comprehensive monitoring report to include policy recommendations to the Regional TESD Committee, as the case may be.

Section 4. **Repealing Clause** - All Ordinances, Resolutions, City Rules and Regulations or parts thereof inconsistent with this Ordinance are hereby repealed or modified accordingly.

Section 5. **Effectivity** - This Ordinance shall take effect upon its approval.
