AN ORDINANCE GRANTING FIL-METRO GAMING CORPORATION AUTHORITY TO OPERATE BINGO HALLS IN METROPOLIS MANUELA, ALABANG, MUNTINLUPA CITY.

WHEREAS, **Fil-Metro Gaming Corporation**, a corporation duly organized and existing under and by virtue of Philippines with principal office at **No. 21 EVP Mansions Riverside Village, Pasig City**, has applied for a permit to establish and operate **Bingo Halls**, Metropolis Manuela. Alabang. Muntinlupa City:

WHEREAS, **Fil-Metro Gaming Corporation** seeks to operate bingo halls in Metropolis Manuela. Alabang. City of Muntinlupa and respectfully requests that the Sangguniang Panglungsod pass an ordinance granting it the necessary franchise and permit to do the same:

WHEREAS, under Republic Act No. 7160 the Sangguniang Panglungsod has the authority to grant franchises, enact ordinances authorizing the issuance of permits and licenses and enact ordinances levying taxes, fees and other charges:

**NOW, THEREFORE, BE IT ORDAINED** by the Sangguniang Panglungsod of Muntinlupa, Metro Manila, in session assembled, that:

**SECTION 1.** There is hereby granted to **Fil-Metro Gaming Corporation** authority to operate a bingo hall in Metropolis Manuela. Alabang. Muntinlupa City, or in any one (1) area in Muntinlupa approved by **PAGCOR**. This ordinance is understood to be for one (1) venue only.

**SECTION 2.** Metro Gaming Corporation shall secure a Mayor's Permit for the operation of the bingo halls:

**SECTION 3.** The authority to operate bingo halls granted herein shall be limited as follows:

a. The holding of bingo games shall be in accordance with the Rules and Regulations as promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR);

b. The operation of bingo hall shall not include the playing of games not related to or other than bingo.

**SECTION 4.** Upon approval of this ordinance, the Fil-Metro Gaming Corp. Shall remit to the City Treasurer the amount prescribed under the existing franchise tax of the City which is payable yearly/annually at the rate of fifty percent (50%) of one percent (1%) of the gross annual receipts pursuant to Section 137 of Republic Act No. 7160:

**SECTION 5.** The grant of authority to operate bingo games hereinabove mentioned shall be for a period of five (5) years, from date of approval.


**SECTION 6.** This authority to operate bingo games is given upon the representation of the Fil-Metro Gaming Corporation that the same is a requirement in its application for a permit and license to operate bingo in the **Philippine Amusement and Gaming Corporation (PAGCOR)**. Should the PAGCOR do not give a license or permit to operate bingo to Fil-Metro Games Corporation, this ordinance shall be considered without force and effect.

**SECTION 7.** This Ordinance shall take effect upon its approval.


