WHEREAS, on 14 October 1996. Ordinance No. 96-90 was approved which provide for Twenty Thousand Pesos (P20,000.00) burial assistance to surviving World War II Veterans;

WHEREAS, the widows of the World War II Veterans are requesting that they be granted also burial assistance by the City Government:

WHEREAS, the qualified widows shall be the legal heirs of the World War II Veterans of Muntinlupa as duly certified by the Veterans Federation of the Philippines. Muntinlupa-Las Pinas District:

WHEREAS, the City Government is allowed under Sec. 9 of R.A. 7696 to grant ditional benefits to the veterans which is quoted as follows, to wit:

> "Section 9 - Additional benefits from Local Government- Notwithstanding any existing laws, rules and regulations, veterans and their dependents and survivors who receive such benefits under Republic Act 6948 may also receive any additional benefit granted by their respective Local Government Unit."

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the Sangguniang Panglungsod the following:

Section 1. The amount of Twenty Thousand Pesos (P20,000.00) is granted as survival assistance in case a widow of **World War II Veterans** dies, which amount shall be given to the legal heir (s) of said widow.

Section 2. The amount shall be taken from the Five Hundred Thousand Pesos (P500,000.00) allocated for the World War II Veterans.

Section 3. The members of the Veterans Federation of the Philippines. Muntinlupa - Las Pinas District shall submit within sixty (60) days upon approval the names of their surviving spouse.

Section 4. Effective Clause. This ordinance shall be made effective on 1 June 1997.
