WHEREAS, the bid price offered by the lowest bidder is Two Million One Hundred Sixty-Five Thousand Pesos (P2,165,000.00) which is 9.88% and 3.57% above the Approved Agency Estimate (AAE) and Allowable Government Estimate (AGE), respectively:
