Whereas, on June 4, 1996 the City Government of Muntinlupa was informed by Milda Alvior, Director IV, Department of Social Welfare, that Muntinlupa has been chosen as recipient of the initial slot for the establishment of Model Senior Citizens Day Center, and that, P 1,000,000.00 have been allocated for the project from the net sales of the Bases Conversion Act;

Whereas, in order that the Center can be put up, the City Government was required to provide the site with an area of at least 500 to 1,000 square meters pursuant to Article 8 of R.A. *1*876:

Whereas, The City government has a parcel of land titled in its name under Transfer Certificate of Title no. 107155 with an area of 2,190 square meters, more or less located Barangay Cupang, Muntinlupa City, a portion of the said parcel of land is now being occupied by the Cupang Barangay Hall;

Whereas, a portion of this land with an area of 500 to 1000 sq. m. can be allocated as site for the Model Senior Citizens Day Center;

Whereas, the Barangay officials thru the Barangay Chairman, Hon. Artemio A. Simundac have given their conformity to this intention to put up the Center in said place;

Resolve, therefore, as it is hereby Resolved that an area from 500-1,000 square meters from the proposed Plaza of Barangay Cupang, Muntinlupa City covered by TCTNo. 107155 with a total area of 2,190 be allocated as site of the "Windel Senior Citizens Day Center";
