AN ORDINANCE GRANTING FIRST IMPERIAL CARGO, INC. AUTHORITY TO HALLS **OPERATE BINGO METROPOLIS** IN MANUELA, MUNTINLUPA CITY.

WHEREAS, First Imperial Cargo, Inc., a corporation duly organized and existing under and by virtue of the Laws of the Philippines with principal office at No. 113 Roxas Boulevard, Baclaran, Parafiaque, Metro Manila has applied for a permit to establish and operate Bingo Halls at Metropolis Manuela, Alabang, Muntinlupa City,

WHEREAS, First Imperial Cargo, Inc., seeks to operate bingo halls in Metropolis Manuela, Alabang, City of Muntinlupa and respectfully requests that the Sangguniang Ranglungsod pass an ordinance granting them the necessary franchise and permit;

WHEREAS, under Republic Act No. 7160 the Sangguniang Panglungsod has the authority to grant franchises, enact ordinances authorizing the issuance of permits and licenses Vevying taxes, fees and other charges;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panglungsod of Muntinlupa City, Metro Manila, in a session assembled that:

SECTION 1. There is hereby granted to First Imperial Cargo, Inc., authority to operate a bingo halls in Metropolis Manuela, Alabang, Muntinlupa City approved by PAGCOR. This ordinance is understood to be for one (1) venue only;

SECTION 2. First Imperial Cargo, Inc., shall secure a Mayor's Permit for the operation of the bingo hall;

SECTION 3. The authority to operate bingo halls shall be limited to the following:

- a. The holding of bingo games shall be in accordance with the Rules and Regulations as promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR):
- b. The operation of bingo halls shall not include the playing of games not related to or other than bingo.

SECTION 4. Upon approval of this ordinance, the First Imperial Cargo Inc., shall remit to the City Treasurer the amount prescribed under the existing franchise tax of the City which is payable yearly/annually at the rate of fifty percent (50%) of one percent (1%) of the gross annual receipts pursuant to Section 137 of Republic Act No. 7160;

SECTION 5. The grant of authority to operate bingo games hereinabove mentioned shall be for a period of five (5) years from date of approval. This approval is without prejudice to any subsequent taxation or taxes that might be imposed by the City Council on the operation of Bingo Halls within the City;

SECTION 6. This authority to operate bingo games is given upon the representation of the First Imperial Cargo, Inc., that the same is a requirement in application for a permit and license to operate bingo in the Philippine Amusement and Gaming Corporation (PAGCOR). Should PAGCOR do not give a license or permit to operate bingo to First Imperial Cargo, Inc., this ordinance shall be considered without force and effect.

SECTION 7. This Ordinance shall take effect upon its approval.
