WHEREAS, the floods and stagnant water is a threat to the health and life of the people in Lower Sucat, and that, there is a need for an immediate construction of the drainage and sidewalk;

WHEREAS, the City Government has a budget from the Calamity Fund, 1997 Executive Budget;

NOW THEREFORE, BE IT ORDAINED, that the amount of One Million Two Hundred Thousand Pesos (P1,200,000.00) be allocated for the Construction of Drainage and Sidewalk in Lower Sucat, Muntinlupa City, which amount shall be taken from the Calamity Fund, 1997 Executive Budget.
