AN ORDINANCE ALLOCATING THE AMOUNT OF THREE MILLION PESOS (P3,000,000.00) FOR THE PROJECT, PROPOSED ROAD ASPHALTING, PHASE II, AT DON JUAN BAYVIEW SUBDIVISION, SUCAT, MUNTINLUPA CITY.

WHEREAS, the roads in Don Juan Bayview, in view of the on-going construction of the Skyway, are being used as alternate routes of vehicles coming from Bagumbayan to the Expressway and vice-versa;

WHEREAS, last August 18, 1997, said roads were heavily damaged because of heavy rains and typhoon that passed the country. The heavy rains caused strong floods that carved out the soil and damaged the asphalts rendering the said roads impassable;

WHEREAS, there is an on-going Project (Road Asphalting) in the said area with a budget of Two Million Eight Hundred Eight Thousand Five Hundred Twenty Two Pesos and 90/100 (P2,808,522.90), said amount is not sufficient to asphalt all the damaged roads;

WHEREAS, there is a need to allocate additional Three Million Pesos (P3,000,000.00) to complete the asphalting of the damaged roads;

WHEREAS, there was a previous declaration from the President that Metro Manila was under a Calamity Area by reason of the heavy rains, floods and typhoon that passed over the country;

NOW THEREFORE, BE IT ORDAINED, that the amount of Three Million Pesos-(P3,000,000.00) be allocated for the Project (ROAD ASPHALTING, Phase II) at Don Juan Bayview Subdivision, Sucat, Muntinlupa City, which amount shall be taken from the Calamity Fund, 1997 Executive Budget.
