WHEREAS, on October 1997, a Writ of Demolition was assued by the Regional Trial Court Branch 276 in Muntinlupa City directing the Court Sheriff to implement the Special Order dated 23 September 1996 for the immediate demolition, removal and tear down of any and if improvements introduced by Plaintiffs on the area which is the subject of road widening by the Muntinlupa Government:

WHEREAS, Sheriff Antonio D. Blancaflor of RTC Branch 276 issued a notice to the Plaintiffs in Civil Case No. 13006 giving them until 22 October 1997 within which to voluntarily vacate and demolish their improvements affected by said road widening.

WHEREAS, on 10 October 1997, the Court issued an order suspending the enforcement of the Writ of Execution insofar as the property of Plaintiff Loida Joaquin is concerned.

WHEREAS, the plaintiff in Civil Case No. 13006 appeared before the Sangguniang Panglungsod and requested for assistance for the deferment of the enforcement of the Writ at Execution and the Writ of Demolition on the allegation that they have valid titles to their respective properties which will be affected by the road widening project of the Muntinlupa City Government.

WHEREAS, said plaintiffs have assailed the validity of the Compromise Agreement on the allegation that the conditions therein were not duly complied with and that the submission of the required survey plan was done through fraud:

WHEREAS, pursuant to Resolution No.97-66 of the Sangguniang Panglungsod which was adopted on 4 August 1997, Mayor Ignacio R. Bunye was granted an authority to enter into a contract for the ROAD WIDENING of Montillano Street, provided that no one shall be unjustive prejudiced, copy of this Resolution is hereto attached as Annex "A
