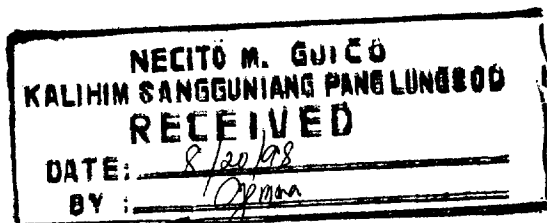

WHEREAS, from April, 1998 up to the present, the Muntinlupa Polytechnic College is just using a temporary service wire connection for its lighting facilities;

WHEREAS, The temporary service wire is just being tapped at the nearby Katarungan Village residential houses going to the Muntinlupa Polytechnic College;

WHEREAS, the computers in the school cannot be used by the students because of low voltage;

WHEREAS, There is an immediate need to install permanent wire service connecting the Muntinlupa Polytechnic College and the Meralco power lines with sufficient voltage;

WHEREAS, there is no water in the school because, as of now, there is no deepwell installed;

WHEREAS, the school is just getting water delivered by the fire truck coming from the Bureau of Fire Protection;

WHEREAS, the needed funds for the projects per bill of Materials prepared by the Engineering Office are as follows:

P 618,443.96 for the installation of the deepwell;

P 1,035,715.04 for the installation of service wire and street lights, and

P 148,560.00 deposit for Meter Service in the Manila Electric Company.
