



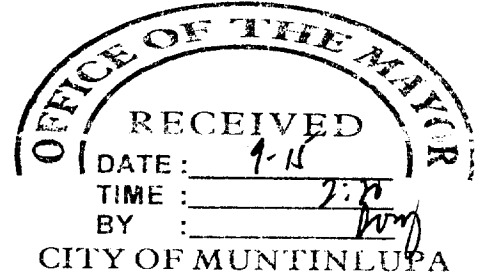

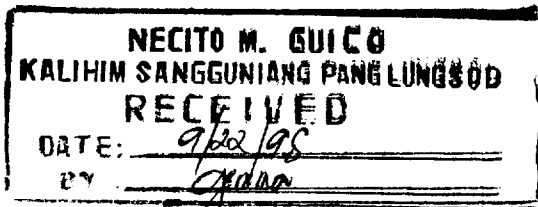

WHEREAS, in putting up the office in the City Hall Annex will require a budget cost of Four Hundred Seventy Thousand Pesos (P 470,000.00) for masonry, security grills, wooden partition, open shelves, aluminum doors, ledge with drawers, electrical works, painting works and miscellaneous expenses, per bill of materials prepared by the City Engineering Office.

RESOLVE, AS IT IS HEREBY RESOLVED, that the amount of Four Hundred Seventy Thousand Pesos (P 470,000.00) be allocated for the putting up of the Registry of Deeds Office in the City Hall Annex, which amount shall be taken from the Community Development Fund (CDF) for 1998.
