

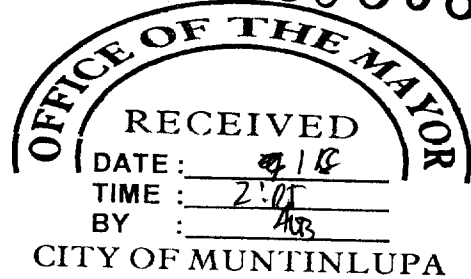

WHEREAS, Republic Act No. 8505 provides assistance and protection for rape victims and establishes a Rape Crisis Center in every province and city;

WHEREAS, pursuant to this law, the project, The Muntinlupa Family Crisis Response Center is launched to eradicate Violence against women and children;

WHEREAS, this project is implemented by the city government thru the Office of the City Prosecutor, PNP, Muntinlupa Police Department, private Foundations/Association such as ABS-CBN Foundation Inc., Philippine Medical Women's Association, Muntinlupa Medical Society, Muntinlupa Development Foundation, and the Zonta Club of Muntinlupa and Environs Foundation, Inc., the lead organization;

WHEREAS, the City provides the necessary personnel and office space at the 2nd floor of Contessa Building, Poblacion, Muntinlupa City, for the project;

WHEREAS, the Muntinlupa Family Crisis Response Center needs operational expenses.

NOW, THEREFORE,

RESOLVE, AS IT IS HEREBY RESOLVED, that the amount of P500,000.00 be allocated for operational expenses of the project, the Muntinlupa Family Crisis Response Center, which amount shall be taken from the Community Development Fund for 1998.
