#### **ORDINANCE NO. 98-006**

AN ORDINANCE REQUIRING MUSIC BARS, LOUNGES, RESTAURANTS, MOVIE HOUSES, AMUSEMENT AND DANCE HALLS, ASSEMBLY HALLS, CLUBS, EDUCATIONAL, MERCANTILE, AND SIMILAR ESTABLISHMENTS TO DISPLAY THEIR FLOOR PLANS IN CONSPICUOUS PLACES AND TO INSTALL BATTERY-OPERATED AUTOMATIC EMERGENCY LIGHTS IN THEIR RESPECTIVE ESTABLISHMENTS.

WHEREAS, Article 3. Rule 1 of the RULES AND REGULATIONS IMPLEMENTING BY THE LOCAL GOVERNMENT CODE OF 1991 provides that "LGUs shall ensure and support, among other things, within their respective territory, the promotion of health and safety... and the preservation of the comfort and convenience of their inhabitants."

WHEREAS, Sec. 11 (d) Article V of R.A 7926 provides that "the Sangguniang Panlungsod shall regulate activities relative to the use of land, buildings and structures within the City in order to promote the general welfare";

WHEREAS, it is the policy of the *City of Muntinlupa* to promote the general welfare and to ensure public safety for the best interested of its constituents;

WHEREAS, to protect the people from any emergency brought about by any natural or man-made calamities or accidents, it is necessary to enact this ordinance;

#### NOW, THEREFORE,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the following be enacted by the Sangguniang Panlungsod of Muntinlupa;

**SECTION 1.** Pursuant to the above policy, owners of music bars, lounges, restaurants, movie houses, amusement and dance halls, clubs, educational, mercantile and similar establishments are required to display their floor plans in conspicuous places and to install battery-operated automatic emergency lights in their respective establishments.

**SECTION 2.** The Tax and License Division is hereby mandated to strictly monitor the implementation of this ordinance and shall impose the following penalty for any violation thereof:

a. First Offense

- Written Warning

b. Second Offense

 Outright Revocation of Permit to Operate

SECTION 3. In addition to the outright revocation of permit to operate, any violation of this ordinance shall be punished upon conviction by a fine of Five Thousand Pesos (P 5,000) or 2 months imprisonment, or both, upon the discretion of the court; if the offender is a Firm, Company, Association, Corporation or Partnership, the President, General Manager, Chairman of the Board of Directors or Managing Partner shall be held liable for the penalty or penalties herein provided.

**SECTION 4.** This ordinance shall take effect after **15 days** from the date a copy thereof is posted in a bulletin board at the entrance of the City Hall of Muntinlupa, and in at least two (2) other conspicuous places in the City of Muntinlupa.

ENACTED, by the City Council of Muntinlupa this 14<sup>th</sup> day of September 1998 on its 10<sup>th</sup> Regular Session.
