AN ORDINANCE GRANTING ALABANG NUMBERS AND GAMING CORPORATION AUTHORITY TO OPERATE BINGO HALL AT FESTIVAL SUPERMALL, ALABANG, MUNTINLUPA CITY.

WHEREAS, Alabang Numbers and Gaming Corporation is a Corporation duly organized and existing under and by virtue of the Laws of the Philippines with principal office at # 147 Elizalde S. BFEV, Las Piñas, Metro Manila has applied for a permit to establish and operate Bingo Hall in Festival Supermall, Alabang, City of Muntinlupa;

WHEREAS, Alabang Numbers and Gaming Corporation seeks to operate Bingo Hall in Festival Supermall, Alabang, City of Muntinlupa and respectfully requests that the Sangguniang Panglungsod passed an ordinance granting it the necessary franchise and permit to do the same;

WHEREAS, under Republic Act No. 7160, the Sangguniang Panglungsod has the authority to grant franchise by enacting ordinances authorizing the issuance of permits and licenses and levying taxes fees and other charges;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panglungsod of Muntinlupa the following :

SECTION 1. Alabang Numbers and Gaming Corporation is hereby granted authority to operate Bingo Hall in Festival Supermall, Alabang, Muntinlupa City. This ordinance is understood to be for one (1) venue only.

SECTION 2. Alabang Numbers and Gaming Corporation shall secure a Mayor's Permit for the operation of the Bingo Hall.

SECTION 3. The authority to operate Bingo Hall granted herein shall be limited as follows:

- a. The holding of bingo games shall be in accordance with the Rules and Regulations as promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).
- b. The operation of bingo hall shall not include the playing of games not related to or other than bingo.

**SECTION 4.** Upon approval of this ordinance, the Alabang Number and Gaming Corporation shall remit to the City Treasurer the amount prescribed under the existing franchise tax of the City which is payable yearly/annually at the rate of fifty (50%) of one percent (1%) of the gross annual receipts pursuant to Section 137 of Republic Act No. 7160 :


**SECTION 5.** The grant of authority to operate bingo games hereinabove mentioned shall be for a period of ten (10) years from date of approval.

**SECTION 6.** This authority to operate bingo games is given upon the representation of the Alabang Numbers and Gaming Corporation that the same is a requirement in its application for a permit and license to operate bingo in the Philippine Amusement and Gaming Corporation (PAGCOR). Should the PAGCOR do not give a license or permit to operate bingo to Alabang Numbers and Gaming Corporation, this ordinance shall be considered without force and effect.

**SECTION 7.** This Ordinance shall take effect upon its approval.


