AN ORDINANCE ALLOCATING THE AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (P800,000.00) FOR THE PURCHASE OF FOODS, MEDICINES, COCO LUMBERS AND OTHER SUPPLIES/MATERIALS FOR DISTRIBUTION TO THE RESIDENTS OF MUNTINLUPA CITY AFFECTED BY THE CONTINUOUS HEAVY RAINS AND FLOODS, WHICH AMOUNT SHALL BE TAKEN FROM THE SPECIAL ACTIVITIES FUND OF THE CITY COUNCILORS AND CITY VICE MAYOR OR FROM THE CALAMITY FUND.

WHEREAS, on August 3, 1999, His Excellency, President Joseph E. Estrada declared as in a state of calamity Metro Manila and other nearby provinces due to strong floods brought about by continuous heavy rains;

WHEREAS, the City Council passed and approved Resolution No. 99-122 declaring the City of Muntinlupa as in a state of calamity;

WHEREAS, due to the heavy rains and floods, there are so many houses along the Laguna de Bay from Sucat to Tunasan, Muntinlupa City that are under water;

WHEREAS, aside from those living along the Laguna de Bay, residents near the creeks, and low lying areas are also affected by the floods;

WHEREAS, due to the heavy rains and floods, the people affected are asking/requesting for assistance;

WHEREAS, there is an urgent need to help the residents affected by the heavy rains and floods;

WHEREAS, the Eight Hundred Thousand Pesos (P800,000.00) shall be taken from the Special Activities Fund of the City Councilors (P50,000.00 from each Councilor) and Vice Mayor (P100,000.00)

WHEREAS, of the Eight Hundred Thousand Pesos (P800,000.00), One Hundred Thousand Pesos (P100,000.00) shall be for the Vice Mayor and Fifty Thousand Pesos (P50,000.00) for each Councilor to be used in the purchase of foods, medicines, coco lumbers and other necessary supplies/materials *for distribution to the residents affected* by the heavy rains and floods.

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED that the amount of Eight Hundred Thousand Pesos (P800,000.00) for the purchase of foods, medicines, coco lumbers and other necessary supplies/materials for distribution to the residents of Muntinlupa City who are affected by the heavy rains and floods, which amount shall be taken from the Special Activities of the City Councilors and City Vice Mayor or from the Calamity Fund, *be approved*.


