AN ORDINANCE REPEALING ORDINANCE NO. 98-018 REQUIRING OWNERS, OPERATORS, LESSES, OCCUPANTS AND CONCESSIONAIRES OF BUSINESS ESTABLISHMENTS, CONTRACTORS, AND DEVELOPERS, AND PERSONS REQUIRED TO SECURE BUSINESS AND/OR BUILDING PERMITS IN DOING BUSINESS OR UNDERTAKING CONSTRUCTION OR REPAIR WORK IN MUNTINLUPA CITY TO SECURE PUBLIC LIABILITY INSURANCE PROVIDING PENALTIES FOR VIOLATIONS THEREOF AND FOR OTHER PURPOSES.
