ORDINANCE NO. 99-040

AN ORDINANCE REGULATING THE ESTABLISHMENT OF BINGO, ON-LINE BINGO, JAI-ALAI (OFF-FRONTON), HORSE RACING (OFF TRACK) AND OTHER LEGALIZED GAMBLING ACTIVITIES IN THE CITY OF MUNTINLUPA, PROVIDING PENALTIES THEREFOR AND FOR OTHER PURPOSES.

WHEREAS, Sec. 458, Par. 1 (IV) of the New Local Government Code of 1991 empowers the Sangguniang Panlungsod to *“Adopt measures to protect the inhabitants of the city from.....activities inimical to the welfare and morals of the inhabitants of the city;”*

WHEREAS, Sec. 458, Par. 4 of the same Code also empowers the Sangguniang Panlungsod to *“Regulate activities relative to the use of lands, buildings and structures within the city in order to promote the general welfare...;”*

WHEREAS, *there is now a proliferation of legalized gambling activities* in the country such as Bingo, On-line Bingo, Jai-Alai, Horse Racing, and Lotto, aside from the proliferation of illegal gambling activities such as jueteng and other illegal games;

WHEREAS, there is a need to regulate legalized gambling activities in the City of Muntinlupa *to protect our people, especially the youth, from its pernicious effect;*

NOW, THEREFORE, BE ENACTED BY THE SANGGUNIANG PANLUNGSOD IN SESSION ASSEMBLED THAT:

Section I. RESTRICTION. No On-line Bingo, Jai-Alai (Off Fronton), Horse Racing (Off Track) and other legalized gambling activities that may be put up shall be established within the City of Muntinlupa *except in recognized shopping malls to be designated by the City Mayor.*

Section 2. PRIOR SANGGUNIANG PANLUNGSOD APPROVAL AND PUBLIC HEARING REQUIRED. No business permit shall be granted to operators of on-line bingo and other legalized gambling activities *without the prior approval of the City Council in a resolution duly passed and without conducting a Public hearing* for the purpose.

Section 3. ENFORCEMENT. The City Mayor *is hereby granted full authority to enforce this ordinance* including the issuance of rules and regulations for the effective implementation of this ordinance.


Section 4. PENALTIES. Any person or entity found violating this ordinance *shall be fined and/or penalized* in the amount of Five Thousand Pesos (P5,000.00) or imprisoned for one year, or both at the discretion of the court.


Section 5. SEPARABILITY CLAUSE. If for any reason a part or provisions of this ordinance is declared illegal or unconstitutional by a competent court, the *other provisions not affected thereby shall remain valid and existing.*

Section 6. EFFECTIVITY. This ordinance shall take effect *upon its approval.*


