WHEREAS, under the Rules and Regulations Implementing the Local Government Code of 1991, as amended, the City Council has, among others, the following powers:

- 1) Approve ordinances and pass resolutions necessary for an efficient and effective city government, and relative thereto, shall:
 - (viii) Determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the city government;
 - (ix) Authorize the payment of compensation to a qualified person not in the government service who fills up a temporary vacancy or grant honorarium to any qualified official or employees designated to fill a temporary vacancy in a concurrent capacity, at the rate authorized by law;
